



SUMMARY ANNUAL REPORT

FOR COLUMBIA UNIVERSITY RETIREE MEDICAL AND LIFE INSURANCE BENEFITS PLAN

This is a summary of the annual report of the Columbia University Retiree Medical and Life Insurance Benefits Plan, EIN 13-5598093, Plan No. 517, for the period July 01, 2009 through June 30, 2010. The annual report has been filed with the Employee Benefits Security Administration, U.S. Department of Labor, as required under the Employee Retirement Income Security Act of 1974 (ERISA).

Insurance Information

The Plan has a contract to pay health claims incurred under the terms of the Plan. The total premiums paid for the Plan year ending June 30, 2010 were \$57,127.

Basic Financial Statement

The value of Plan assets, after subtracting liabilities of the Plan, was \$106,792,237 as of June 30, 2010, compared to \$90,958,288 as of July 01, 2009. During the Plan year the Plan experienced an increase in its net assets of \$15,833,949. This increase includes unrealized appreciation and depreciation in the value of Plan assets; that is, the difference between the value of the Plan's assets at the end of the year and the value of the assets at the beginning of the year or the cost of assets acquired during the year. During the Plan year, the Plan had total income of \$27,670,554, including employer contributions of \$15,096,369, employee contributions of \$3,622,479, and earnings from investments of \$8,951,706.

Plan expenses were \$11,836,605. These expenses included \$231,472 in administrative expenses, and \$11,605,133 in benefits paid to participants and beneficiaries.
